BIKES/SKATEBOARDS/HELMETS: Students will not ride to school with more than 1 rider per bike/skateboard. Bikes/skateboards will not be ridden on school property. BUS : Students will behave appropriately and respectfully on the <u>bus</u> . MOBILE DEVICES

- **1st** confiscation: returned to student at end of the school day plus 30 min. detention

- **4**th confiscation: electronic device released to parent and conference with Administration/Parents to discuss revoking cell phone privileges.
- Possession of a laser pen will result in confiscation and a detention.
- Use of laser pen on another person = suspension

PHYSICAL CONTACT: Students will not fight or engage in intimidating behavior. COMPUTER USE: Students are expected to follow the guidelines for responsible computer use as outlined in the District "Acceptable Use Policy" (AUP). TOBACCO/NICOTINE: Students will not use or possess tobacco or nicotine in any form including e-cigarettes or vapes at school, to and from school, or at school events.	 1st offense = **ATOD, Suspension, Possible Police Intervention, Parent Contact, *SST Referral 2nd offense = Suspension, Police Intervention 3rd offense = Recommendation for Alternative School Placement
ALCOHOL/DRUGS: Students will not possess or be under the influence of alcohol or drugs or possess paraphernalia (this includes drug and alcohol paraphernalia/look-a-likes) at school, to and from school, or at school events.	 1st offense = 5 Day Suspension, *SST Referral to Police Intervention, Parent Contact 2nd offense = Referral to *SST, Recommendation for Alternative School Placement
CONTROLLED SUBSTANCES: Students will not sell or furnish controlled substances.	 5 day suspension, Parent Contact, Referral to *SST, Police Intervention, Recommendation for Expulsion
SCHOOL/PERSONAL PROPERTY: Students will not steal, deface or vandalize school or personal property. This includes using other people's lunch numbers.	1 to 5 day suspension, Parent Contact, Restitution, Possible Police Intervention
<u>DANGEROUS EQUIPMENT</u> : Students will not possess weapons* of any kind or a facsimile of a weapon including paint ball equipment.	 Confiscation, 1 to 5 day suspension, Parent Contact, Referral to *SST, Possible Police Intervention, Possible Recommendation for Expulsion
INCENDIARY DEVICES: Students will not possess or use explosives/incendiary devices (including matches or lighters), pull fire alarms, or commit arson. Aerosol cans are not allowed on campus or in the locker rooms!	Confiscation, 1 to 5 Day Suspension, Parent Contact, Possible Referral to Law Enforce- ment, Possible recommendation for Expul- sion.
WEAPON: Students will not brandish a "weapon" or possess, sell or furnish a firearm. *A weapon can be any object with the potential to cause harm which is used to threaten or injure another person.	Mandatory Expulsion, Parent Contact, Referral to Law Enforcement

L. O. P. (LOSS OF PRIVILEGE LIST)

If you are involved with a referral or LOP infraction, the administration may (at their own discretion), place your name on an LOP List. For the period of time your name is on the list, you may not participate in any extracurricular activities. This includes school dances, field trips, and night events.
