# **GENERAL RULES & GUIDELINES**

## **BIKES/SKATEBOARDS/HELMETS**

Bicycles and skateboards must be parked and should be LOCKED in the bike compound near the staff parking lot at all times. The compound is open before and after school each day. Bicycles/skateboards are NOT to be ridden on campus, on the sidewalks or in the parking lot. WALK IT! LOCK IT! LEAVE IT!

#### IT'S YOUR BIRTHDAY???/VALENTINE'S DAY???

NO BALLOONS, FLOWERS, or BIRTHDAY TREATS (i.e. cupcakes, etc.) are allowed at school. Celebrations should be reserved for after school. Additionally, celebrations involving food are prohibited for health, cleanliness, and safety reasons.

#### **MOBILE TECHNOLOGY**

Technology today is integral to many of the tasks and assignments students will need to complete at school and at home. CVMS values COURTEOUS, EFFICIENT, and APPROPRIATE use of technology to enhance the learning environment and optimize access to learning and efficient work habits. Personal use, under the discretion of school staff, Smart phones/iPhones, e-readers, tablets, and laptops may be used at school to support learning. Use of technology in the classroom is at the discretion and under the supervision of each classroom teacher for instructional purposes only. Students must leave devices on the teacher's desk if going to the restroom during class time. Abuse of the privilege of using technology (violation of the Acceptable Use Policy) may result in suspension of this privilege.

#### \*NOTICE OF NON-RESPONSIBILITY

SDUHSD is NOT responsible for the personal property, or money of students or employees. Personal items are brought to school at the owner's risk. Please remember to mark all items with your name. LOCK your bike, skate-board and PE locker at all times and don't share locker combination with friends. (Refer to page 16)

#### **PARENT CALLS & MESSAGES**

We limit classroom interruption! Lunches, supplies, forgotten books and assignments, or telephone messages cannot be delivered to students in class. If your parents dropped something off for you, please check the message board outside the Attendance Office whenever you forget an item.

#### **REPORT CARDS/AERIES PORTAL**

24 hours a day, 7 days a week, students and parents can check on the Aeries Portal for homework assignments, grades, etc. All progress reports and semester report cards are posted on Aeries and will not be mailed home.

#### **TEXTBOOKS**

Students are responsible for textbooks checked out to them at the start of the year until they return them at the end of the year. (1) Students will pay for books lost, stolen, damaged, or if books indicate careless use. (2) Students can only turn in their assigned books.

#### **IDENTIFICATION ON CAMPUS**

To provide a safe campus, adults must enter the campus through the front office where they will produce a valid ID to be run through our RAPTOR system that clears their presence on our campus. The CVMS campus is CLOSED to all student visitors from other schools. Students are expected to carry their student ID card while on campus.

#### ORDERING FOOD TO THE SCHOOL

Students are not permitted to order food from outside vendors for delivery at CVMS. Students need to bring a lunch or purchase one from the Bobcat Grill.

#### **CHANGE OF ADDRESS**

Students are required to provide proof of residency to the Registrar when submitting a change of address or telephone number. All students are required to have an emergency card on file with a telephone number and email address where their parents can be reached during the school day.

# SDUHSD ACADEMIC HONESTY POLICY

Honest behavior is an expectation for all students in the San Dieguito Union High School District. The purpose of this regulation is to create and maintain an ethical academic atmosphere.

## SPECIFIC TYPES OF ACADEMIC DISHONESTY NOT TOLERATED ARE DEFINED BELOW:

- 1. Cheating: (assignments, tests, quizzes, examinations, running laps) Any intentional giving of or use of external assistance relating to an examination, test, quiz or assignments without express permission of the teacher. This includes looking on another student's paper, sharing answers, copying another student's paper, talking during a test (it does not matter what you are talking about), using an electronic device without permission during a test or assignment or cutting corners during the Superlap/Mile Run in PE.
- 2. <u>Fabrication:</u> Any intentional falsification or invention of data citation, or other authority in an academic exercise.
- 3. <u>Unauthorized Collaboration:</u> While collaboration is often encouraged, unauthorized collaboration is not permitted. (Make sure you have teacher permission.)
- **4.** <u>Plagiarism:</u> Any intentional representation of another's ideas, words, or work as one's own. Plagiarism includes the misuse of published material, electronic material, and/or the work of other students. The original writer who intentionally shares his/her paper for another to copy, without the permission of the teacher, is also engaged in plagiarism.
- 5. <u>Alteration of Materials:</u> Any intentional and unauthorized alteration of student, teacher, or library materials.
- 6. Forgery: Any unauthorized signing of another person's name to school related documents.
- 7. **Theft:** Any theft of materials.
- 8. Transfer of Unauthorized Materials: Any giving or selling of unauthorized material.

## **CONSEQUENCES FOR ACADEMIC DISHONESTY**

Any alleged violation of this policy will be investigated thoroughly and appropriate disciplinary measures will be taken consistent with SDUHSD School Board policy.

Depending on the severity of the offense, one or more of the following consequences may occur:

- Referral to the Assistant Principal and the parent/guardian will be contacted.
- Loss of all credit for the assignment or test with no makeup permitted.
- Placement on an Academic Honesty Contract.
- Detention

If repeated, the consequences are more severe and include:

- Referral to the Student Study Team (SST).
- Suspension from school, which includes school activities (i.e., dances, etc.).
- Removal from all elected or appointed leadership positions for the remainder of the school year.
- Violation on a school administered national/state exam will result in a district code of conduct violation

# SCHOOL DRESS CODE

Carmel Valley Middle School respects the right of students to express themselves in the attire that they choose to wear. Clothes worn to school should be appropriate for school activities and not distracting to the educational environment. CVMS administration reserves the right to determine what is appropriate dress. When a violation of the dress code occurs, the student will be required to wear a "loaner" for the day, return home for proper attire, or have clothing brought from home to school. Continued violations of the dress code will be considered defiance and will be referred to the Assistant Principal for disciplinary action.

Clothing and accessories (including backpacks) that include the following are unacceptable and not allowed on campus:

- advertise and/or promote drugs, alcohol, vape, and/or tobacco products;
- display vulgar or sexually suggestive language or symbols
- advocate or depict illegal, violent, or lewd conduct conduct, and/or depict weapons
- discriminate against race, ethnicity, gender, gender identity, sexual orientation, religious affiliation, or any other protected classification
- advertise, suggest, or promote gang affiliation
- Footwear must be worn at all times. Sandals, flip-flops, slippers, and high heeled/open toed shoes are not safe, and are highly discouraged.
- Clothing must adequately cover the body. Undergarments must not show.
- All pants and shorts must be secured at the waist.
- Student appearance, including makeup, piercings, or accessories, may not cause distractions or safety concerns in any way to the student or to the school environment.
- Sunglasses, hats, caps, beanies, gloves and/or hoods must be removed immediately upon entering any building or classroom.
- Cloth face coverings may only be worn to protect against the risk of infection, and must be removed upon request as positive identification of students, staff, and parents is necessary for school safety.

## **CONSEQUENCES FOR VIOLATION OF CVMS DRESS CODE**

1<sup>st</sup> violation: Warning/student given loaner clothing if cannot provide appropriate

clothes

2<sup>nd</sup> violation: 30 minute detention/student given loaner clothing

3<sup>rd</sup> violation: 1 hour detention/student given loaner clothing

4<sup>th</sup> violation: 2 hours of detention/student given loaner clothing

5<sup>th</sup> violation: Suspension for defiance/student given loaner clothing.

The following behavior and consequence charts outline general policies and procedures. Each behavior incident is considered individually and appropriate consequences are assigned given the particular circumstances of the situation. The following information is intended to provide students, parents, and staff with a common understanding of the general expectations and possible consequences for misbehavior.

#### **MOBILE DEVICES**

Students may not take pictures or videos at school unless otherwise directed by a teacher. Abuse of this privilege (violation of the Acceptable Use Policy) may result in suspension of this privilege.

- **1st** confiscation: returned to student at end of the school day plus 30 min. detention
- 2nd confiscation: electronic device released to parent with 60 min. detention
- **3**<sup>rd</sup> confiscation: electronic device released to parent and Friday Night School
- **4**<sup>th</sup> confiscation: electronic device released to parent and conference with Administration/Parents to discuss revoking cell phone privileges.
- Possession of a laser pen will result in confiscation and assignment to \*Friday Night School.
- Use of laser pen on another person = suspension

INCENDIARY DEVICES: Students will not possess or use explosives/incendiary devices (including matches or lighters), pull fire alarms, or commit arson. WEAPON: Students will not brandish a "weapon" or possess, sell or furnish a firearm.  *A weapon can be any object with the potential to cause harm which is used to threaten or injure another person.	Mandatory Expulsion, Parent Contact, Refer- ral to Law Enforcement

## L. O. P. (LOSS OF PRIVILEGE LIST)

If you are involved with a referral or LOP infraction, the administration may (at their own discretion), place your name on an LOP List. For the period of time your name is on the list, you may not participate in any extracurricular activities. This includes school dances, field trips, and night events.

**NOTICE**: The San Dieguito Union High School District is not responsible for the personal property of students or employees. Items such as musical instruments, clothing, jewelry, equipment, bicycles, skateboards, electronic organizers, or other personal property, if brought to school, are at the owner's risk. Please remember to lock your PE locker at all times and not to share the locker combination with friends.

## **TECHNOLOGY USE POLICY**

All students and parents/guardians sign an Acceptable Use Policy (AUP) for technology use on campus. Any violations of the AUP are subject to disciplinary action (See Page 15). The following are major areas covered in the AUP.

- Students use appropriate language, manners and ethics when accessing technology
- Students report problems, abuses, or misuses of technology resources to your teacher, counselor or an administrator.
- Students cannot access others' email accounts.
- Students cannot attempt to bypass or alter computers or our network.
- Students cannot bypass restrictions regarding technology use.
- Students cannot use school computers for:
  - Gaming
  - Commercial purposes
  - Illegal activities

### **EMAIL POLICY**

Student use of email must abide by the generally accepted rules and principles of email etiquette, as well as the guidelines outlined in the AUP. To help keep students safe, students are asked to never give out personal information of any kind through email. Additionally, the following activities are not permitted:

- Sending or displaying offensive messages or pictures;
- Using obscene language;
- Harassing, insulting or attacking others;
- Using another students' login or password;
- Corresponding or meeting with someone through the Internet without the pre-approval of a teacher:
- Accessing or downloading inappropriate materials;
- Reposting a message sent to the user privately without the permission of the person who sent the message.

### **CYBERBULLYING**

Appropriate student behavior that leads to a positive school environment is expected when students use technology. Cyber bullying involves the use of information and communication technologies such as social media applications, text messages, instant messaging, defamatory personal websites, and online personal polling websites, to support deliberate, repeated, and hostile behavior by an individual or group, which is intended to harm others.

Any communication that disrupts or prevents a safe and positive educational environment will also be considered cyber bullying. Students whose behavior is found to be in violation of this policy will be subject to discipline and loss of privileges, up to and including expulsion. Third parties whose behavior is found to be in violation of this policy will also be subject to appropriate disciplinary action.
